### WHAT'S HAPPENING

From the day the Pilgrims first set foot at Plymouth Rock, the cornerstone of American government has been religious freedom.

Millions all over the world look to our nation as a candle in the spiritual darkness that has engulfed culture after culture. This is the land where every individual is free to pray and believe and live out the deepest convictions of his soul. This is the country where faith is regarded as such a precious, profoundly personal thing that it is the first right protected by the First Amendment to the Constitution.


This is the land where pastors have been free to preach the Gospel of Jesus Christ and explore the positive impact of biblical truth on every aspect of the culture. This is the nation where Christians, in the name and for the glory of God, have been free to minister His love and administrate their churches without government interference or regulation.

But all of that is changing – and changing fast – in America today.

Today, government intrusion into the affairs of the Church – spurred on, in many cases, by anti-Christian organizations like American Atheists and the Freedom from Religion Foundation – poses a growing threat to church autonomy and to even the most basic religious liberties – including freedom of speech, freedom to exercise religious beliefs, and freedom of access.

Intimidated by threats (including the possible loss of their church's 501(c)(3) tax exemption), many pastors have stopped exploring the message of the Scriptures as it relates to issues that might be considered "politically sensitive," and stopped exhorting their congregations to obey biblical teaching where it conflicts with the dictates of an increasingly "tolerant" secular culture.

Meanwhile, across America, churches are being denied access to public facilities that are available to other private groups ... denied access to public funds that other private organizations can draw on to help the hurting and underprivileged ... denied the uses of suitable property through arbitrary land ordinances and zoning restrictions. These government roadblocks are increasingly impeding church efforts to evangelize and minister to their communities.


